JSC "Metalferos" is an open type company, mixed ownership type.

The main activity of the entity is the collection and transportation of ferrous metal waste.

- Production of consumer goods, closing, consulting, marketing, brokerage, representation, mediation and hotel services;
- Design, capital construction and assembly works;
- Advertising and trade activities, including the organization of exhibitions, fairs, presentations;
- Repair and servicing of motor and track transport;
- External activities;
- Retail sale of clothing;
- Manufacture of other wearing apparel and accessories;
- Providing medical services to the population;
- Other activities not prohibited by law.
