In 2015, the Joint Stock Company "Drumuri-Criuleni" performed works in a volume of 65 million 287 thousand MDL and in 2016 - 83 million 24 thousand MDL, increasing by over 27%. As a result of the increase in turnover, the average salary per enterprise also increased, reaching 6180 MDL, compared to 5562 MDL in 2015. Due to the revenues obtained, in 2015-2016 for the development of the enterprise 7 million lei were allocated. Also, the Joint Stock Company "Drumuri-Criuleni" has modern pavilions for the storage of anti-skid material and materials for road repair.
