Description of the entity

The state enterprise Hotel "ZAREA" operates on the principles of self-management and selffinancing. The main purpose of the enterprise is the temporary accommodation of teachers and management, delegated to various activities organized by the ministry (seminars, methodical meetings, conferences, etc.) and for the accommodation of pupils in the country and abroad, participants in various competitions, festivals, sports competitions, Olympics, etc. In the hotel are temporarily accommodated also students of boarding schools, invited to various events organized by the leadership of the republic.





The type of activity

- Granting short-term accommodation in the hotel with conditions for conferences; production of goods of sociocultural, plastic purpose;
- trade in beverages, consumed mainly in places without entertainment, in bars and beer halls, cafes;
- retail sale of alcoholic beverages and other beverages;
- retail sale of tobacco products;
- tourism activity.



The hotel is located in the city center surrounded by various buildings and historical monuments. It is a building with 12 floors, with a total area of 6506.8 m.p., the area used is 4929.8 m.p., the living area is 2969.8 m.p. The hotel has a cafe-bar with a capacity of 50 seats with working hours 8.30 -23.00 and a conference room located on the floor with a capacity of 30 seats, laundry and other auxiliary rooms for providing various services. The total number of rooms is 176 in number, for providing accommodation services are used -123 rooms, the final capacity of seats is 271 seats, in standard numbers of 2 and 3 seats- 204 seats, in 2-star numbers 67- seats. All numbers are equipped with refrigerators and color TV, and the additional 2-star numbers with telephones and air conditioners.


